


## GREAT BASIN GLYPH NOTES

Lagomarsino Moves Forward

Final plans for the LAGOMARSINO project are now in full swing! Field work is planned for 6th - 9th of June and 18th - 21st of July, with hopefully a full 10 days in October (more info on future dates to follow). Final plans will be set in the first part of May, and a working group meeting will be set, so it you are interested in participating, watch the web site or give Alanah a call. Nevada Department of Transportation has


generously offered the use of their very sophisticated GPS units for mapping and selected NRAF members will receive special training which they'll pass on to the rest of us in the field. Hotel/motel accommodations are available in historic Virginia City (only 12 miles away), as well as an RV park (reservations will be needed EARLY on that) and car pooling will be required for those who choose to stay in VC. Campsites will also be established prior to the beginning of work, but there are no designated camping locales with facilities in the area

Archaeology Awareness Week Poster



begin to develop your own "tool kit" and the string grid is the perfect place to start! Please contact Alanah to order.





### Stewardship Program Moves Forward in Nevada

pproximately 25 people attended the Site Steward Nworkshop held in Mesquite on Dec. 13th and 14th. Hosted by NRAF member Mark Henderson, of the Ely BLM Field Office, and Dawna Ferris, of the St. George BLM, instruction was based on the very successful Arizona Site Steward program. Topics covered were safety, communications, need for coordinators, site acquisition, code of ethics, and confidentiality of information. ARPA laws, artifact recognition, and preserving crime scenes were also discussed. The workshop concluded with a field trip to the Mormon Mountains where a number of rock art sites are in need of Stewardship. NRAF is working cooperatively with Archeo-Nevada to develop a badly-needed site stewardship program with the Ely Field Office and plans are underway to spread the program state-wide. Stewards commit to visiting their sites quarterly and filling out a one-page form on site condition which is submitted to the local land manager since we're visiting our favorite sites anyway, we may as well be helping to manage them at the same time! ### Sloan Canyon Dedication

BLM officials, four Senator's and 350 guests came together on February 17th to celebrate the establishment of Nevada's newest National Conservation Area - the Sloan Petroglyph Canyon! It took three years of dedicated effort by Terri Robertson, Helen Mortenson and their team of volunteers (the Friends of Sloan Canyon) to make the 48,000+ acre site a protected "buffer zone" between wilderness areas and rapidly expanding Las Vegas/Henderson. Adjoining property will be auctioned to raise funds to develop public and research facilities. Kudos to NRAF members Terri Robertson and Helen Mortenson for a job well done!



## Code of Ethics

The Nevada Rock Art Foundation subscribes to the following Code of Ethics and encourages its members, as a condition of membership, to abide by the standards of conduct stated herein.

- 1. NRAF members will be respectful at rock art sites many are regarded as sacred by indigenous peoples and as such will be treated as a valued part of our shared cultural heritage.
- 2. All local, state, and national antiquities laws will be strictly adhered to by the membership of NRAF.All research or educational activities taking place at rock art sites shall be subject to appropriate regulations and property access requirements.

- All rock art recording shall be nondestructive with regard to the rock art itself and the associated archaeological remains which may be present.
- 4. NO artifacts shall be collected unless the work is done as part of a legally constituted program of archaeological survey or excavation and with express permission of the land holder.
- 5. No excavation shall be conducted unless the work is done as part of a legally constituted excavation project and with the express permission of the land holder. Removal of soil shall not be undertaken at any time for the sole purpose of exposing subsurface rock art.
